Inner **Envelope No.2** clearly mentioning ‘**Financial Bids**’ for (Name of items) on its top, will be opened **only of those E-tenderers** whose “**Technical Bids**” have been found qualified. The **Financial Bid** should have two copies of **Section-III Part B, Annexure-VI** duly filled up in all respects. The rate quoted in it, should be F.O.R. Destination (Uttarakhand) including Cess, G.S.T, Octroi, Transit Insurance, Unloading, Freight, Inspection/ Testing charges etc.

There will be no negotiations. However, the lowest responsive bidder will attend a meeting of the Purchase Sub-Committee on -----**.2026 at 11:00 AM** for furnishing clarifications, if any.

E-Tenderer or their representative duly authorized by the person signing the E-tender may be present at the time of Bidders Conference, Opening & Finalization of tender. The Tender Committee is empowered to accept or reject those Tender (s) whose authorized representative will not be present on the scheduled dates and time of opening and finalizing the Tender, in case any clarification(s) is required.

Earnest Money Deposit:-

Every tender must be accompanied EMD Demand Draft in favour of U.K. Seeds and Tarai Development Corporation Ltd., Payable at S.B.I.Bank Haldi any scheduled/ Nationalized Bank at Rudrapur, Udham Singh Nagar. Amount of Earnest Money should ordinary range between 2% to 5%. The given percentage will depend on the total cost of the goods as follows :-

- (I) Rs. 25.00 Lakh – 3% and,
- (II) Above Rs. 25 Lakh – 2% shall be charged (Rs. 75,000.00 Minimum)

The parties who had submitted E.M.D. with Tender No. 2026 and have not taken refund so far, need not submit separate E.M.D. However they should clearly indicate the draft No. and amount in proper place.

The bank draft E.M.D. should only be kept in the Envelope No. 1 i.e. “Technical Bids” otherwise the tender will be rejected, summarily.

Conditional E-Tender:-

Any condition such as subject to immediate acceptance, subject to prior sale, shorter validity period or condition for pre-despatch inspection or post inspection of Chemicals etc. may or may not be made by any Inspection Agency/Test Houses, accept or not to accept the Corporation’s decision with regard to the quality of material etc., or in the Tender Documents or separately shall not be considered and all such tenders will be rejected. ***In other words the conditional E-tender will not be considered, under any circumstances.***

Validity:-

The E-Tenderer shall keep the offer open for acceptance for a period of **Sixty days** from the date of **Finalization** of E-Tender. The successful E-tenderers shall have to execute **Agreement** within Seven days after having been called to do so at their own cost.

SECTION-I (PART-A)

GENERAL INSTRUCTION TO E-TENDERER

- 1-1** E-Tenderers are requested to submit their offer in duplicate at Head office, Uttarakhand Seeds And Tarai Development Corporation Ltd., P.O. Haldi-Patharchatta Distt. Udham Singh Nagar on the prescribed proforma annexed hereto as Section III (Part-A) and (Part-B) in the following ways.
- (a) **Inner Envelope No.1 : (Technical Bid with EMD)** Containing 2 Copies of Section III (Part-A) duly sealed Filled up enclosing therewith drafts of Earnest money Photo copies as required in it (in one copy only) and sample if not submitted earlier. Parties who have down loaded their tender form from the website, shall have to enclose prescribed tender fee in shape of draft also. The Technical Bid will be rejected if Annexure VI i.e. Section III (Part "B") Rate Portion is found in Envelop No. 1
- (b) **Inner Envelope No.2: (Financial Bid)** Two copies of prescribed proforma hereto annexed as Section III (Part B) duly filled-up in all respects. Tenderer may have the option to submit only those pages in duplicate related to them alongwith last page of certificate duly signed in each page in the bottom.
- 1-2** Both the Inner Envelope separately sealed (Technical Bid) and (Financial Bid) should be inserted in one envelope called 'Outer Envelope'. This outer envelope should also be sealed and addressed to the Managing Director, Uttarakhand Seeds and Tarai Development Corporation Ltd., Pantnagar, P.O. Haldi, Distt. Udham Singh Nagar, so as to reach before close of E-Tender uploading/receiving. Indicating offer for (Name of item for which rates quoted) under E-Tender No. **R02/SP/2026** items indicating date of opening/downloading -----**2026** on its top. Senders name & address at the left side of envelope to be mentioned.
- 1-3** No erasing or alteration in the text of the tender paper in any of the pages is permitted and any such erasing or alteration will be disregarded or render the whole tender void at the option of the purchase committee until and unless the same has been signed in ink by the person signing the tender along with the stamp of firm/company. Therefore, the tenderer should carefully quote their rates in both the copies.
- 1-4** Offers sent by registered post with acknowledgement due or by courier should only be sent to the Head Office (Haldi) Patharchatta, Pantnagar (District- Udham Singh Nagar). Sealed offers submitted by hand delivery should be delivered to the available at Head Office of the UKS&TDC Ltd., Pantnagar, P.O. Haldi-Patharchatta Distt. Udham Singh Nagar. Cabled or Faxed tenders will not be accepted. Uttarakhand Seeds and Tarai Development Corporation Ltd. Will not be responsible for any postal delay.
- 1-5** Offers with alternative equivalent specifications can be submitted giving sufficient details to show that the alternative would equally serve the purpose. But the decision taken by the Corporation will be final and binding.

1-6 QUOTATION OF PRICE:

- (I) Tenderer should quote rates for the items mentioned in the list of items on F.O.R., destination basis including unloading charges keeping in mind that the material is to be delivered at different destination as detailed in Annexure-IV or as per letter of indent.
- (II) The price quoted shall be deemed to include packing and forwarding charges, Octroi, GST if any.
- (III) The price quoted shall be deemed to include all insurance charges upto destinations. The tenderer shall, therefore, be responsible for the safe delivery at different sites.
- (IV) If it is desired to ask for excise duty or any other charges (tax etc.) as extra this **must be specifically stated with their percentage**. In the absence of any such stipulation, it will be presumed that the price includes all such charges and no subsequent claims will be entertained.
- (V) The price quoted by the tenderers should be inclusive of all taxes including GST as applicable from time to time (and should be clearly stated to be so) which will be paid by the purchaser, if legally leveable at the rate ruling on the date of supply. The rate of any other tax's etc. applicable should be mentioned in the offer.
- (VI) The Tenderer should have their registration with the respective Trade Tax deptt. Which should also be mentioned in the quoted E-tender form. Failing which the resultant responsibility of all legal consequences will lay with the tenderers account and the Corporation will not be responsible for any litigation if arises at any time.
- (VII) The prices quoted for the supply of goods should be firm and not subject to variation by the tenderer. **The rates must be valid at least for 60 days from the date of opening /Finalization**. Shorter validity period will not be considered in any case.
Quantity can be increased/decreased from purchaser's side and approved rates will be valid for entire delivery period and for any additional quantity during the said extended period.
- (VIII) The companies/firms participating in the tender, their constitution/By law/registration papers with the relevant authorities will have to be submitted with the tender offer (In Technical Bid).In addition, the tenders are also required to append attested copies of minimum level of experience, past performance, technical capability, manufacturing facilities/partnership deed etc. and financial position as stipulated in the technical bid (**Annexure-V**).

1-7 EARNEST MONEY :

(a) Amount and mode of deposit:

The amount of Earnest Money as per the schedule given in Tender Notice shall be furnished in shape of Demand Draft in the name of U.K. Seeds and Tarai Development Corporation Ltd. Payable R.T.G.S. in favour of U.K. Seeds and Tarai Development Corporation Ltd., Payable at S.B.I.Bank Haldi and Account No- SBI HALDI 11543877028, IFSC : SBIN0001251 any scheduled/ Nationalized Bank at Rudrapur, Udham Singh Nagar. However the tenderer who has already submitted their Earnest Money against earlier Tender No. 2024, If the same is not refunded earlier, need not submit separate Earnest Money if that covers as per the schedule of the present Tendered value, otherwise difference of the Earnest Money should be deposited to fulfil the tender terms. In case of earnest money for lesser quantity than that of minimum specified herein above is deposited by any tenderer, the Managing Director, UKS&TDC Ltd. Reserves the right to accept or reject such offer.

(B) Forfeiture of Earnest Money:

In the event of a tenderer, whose tender is received within the closing date and time of the tender as specified withdrawing his tender before the receipt of the final decision or in the event of a tenderer, whose tender has been accepted, failing to execute the Agreement in the prescribed form within 7 days after such acceptance shall be made known to him, the Earnest money deposited by such tenderer shall be forfeited without any intimation and in the later case the tender also shall be cancelled.

1-8 SUCCESSFUL TENDERERS:

The tenderer, whose tender is accepted shall be bound to execute an Agreement within 7 days after having been called upon to do so, with Annexure I & II on non-judicial stamp paper with Notary of Rs. 100/- or as prescribed by the Govt. with one extra copy on water mark bond paper, which shall include all salient features of the accepted tender. The cost of stamping the agreements shall be borne by the successful tenderers.

(II) The successful tenderers shall, within the period mentioned above, unless extended by the Corporation, deposit approved Bank draft or the other securities approved by the Corporation, to the extent of 5% of the contract price towards security money in fulfillment of the conditions of the contract in accordance with the relevant clauses, of the General conditions of Contract. The Earnest money as prescribed above deposited by the successful tenderer, will be treated as part of security money for the due fulfillment of the conditions of the Contract in accordance with the relevant clauses of the General condition of the Contract. No interest will be allowed on the Security & Earnest money from the date of its receipt until it is so refunded. 1-10 LAST DATE OF RECEIPT AND OPENING OF TENDER:

The tender should reach at Head office Pathatchatta (Pantnagar), Distt. Udham Singh Nagar (Uttarakhand) upto **5:00 PM**. On 30-04-2026 The Envelope No.1 (Technical Bid) shall be opened at **3:00 P.M.** on 01-05-**2026** in presence of the Committee in public at Head Office Haldi and such tenderers or their authorized representative present at the time of opening. The Envelope No.2 (Financial Bid) will be opened on -----**2026** at **3:00 P.M.** only when necessary formalities are found complete in Technical Bid (Envelope No.1).

1-11 TERMS OF PAYMENT:

Unless otherwise agreed to between the purchaser and the Contractor the standard payment terms, subject to recoveries, if any, under LIQUIDATED DAMAGES CLAUSE' provided in the 'GENERAL CONDITION OF CONTRACT' will be as under :

(a) **For Chemicals :**

100% cost of the materials will be paid within 90 days after receipt of satisfactory test reports of the sample (s) drawn from the lots delivered at site as per specifications mentioned in the Agreement from the recognized test house/ organization decided by the purchaser.

In case the Corporation uses the material of inferior specification, confirmed by the Test House prima-facie, pro-rata deduction as per details mentioned in the clause 3-11 of the Agreement will be made irrevocably. The bank charges etc. shall be borne by the Contracted firm(s). The above payment shall be subject to necessary deductions, if any, towards the liquidated damages or on account of inferior quality on pro-rata basis as per terms of the Agreement. Managing Director of the Corporation reserves the right for the criteria to decide the pro-rata deduction of payment, subject to usability of the product to serve the purpose.

To ascertain the specifications of the material, a representative sample will be drawn by the Corporation in presence of the representative of the suppliers within 3 days of receipt of the material at site excluding holidays and Sundays. If the supplier wish to send his representative at the time of drawing sample, they may do so within three days of receipt of material at site (excluding holidays and Sundays) failing which, it will be presumed that the Supplier is not interested in sending the representative for drawing the sample. The sample drawn by the Corporation will be taken as final and binding to both Contracted firm as well as the Corporation. The cost of Laboratories testing (testing charges) for each consignment shall be borne by the supplier.

(b) ***Deduction from payment.***

Payment as in (a) and (b) above shall be subject to the deductions of any amount for which the Contractor is liable under this Contract in respect of which UKS&TDC Ltd. is the purchaser.

1-12 DELIVERY DATE:

Materials, mentioned above are required by the Corporation as per tentative schedule placed at Annexure IV, therefore, offer must be submitted from the stock available as per delivery schedule of the Contract. The tenderer must state in his tender the dates on which delivery will be completed. Delivery must be completed with the delivery schedule on receipt of the supply order or signing the agreement, otherwise offer/ agreement may be treated as cancelled or subject to liquidated damages as the case may be.

1-13 PERIOD FOR WHICH THE OFFER WILL REMAIN OPEN:

The tenderer shall keep the offer open for acceptance for a period of at least 60 days from the date of finalization of tender. If the day upto which the offer is to remain open has been or is declared to be closed holidays for the office of the U.K.

Seeds and Tarai Development Corporation Ltd., the offer shall remain open for acceptance till the next working day.

1-14 RIGHT FOR ACCEPTANCE:

Any conditions such as the 'SUBJECT TO IMMEDIATE ACCEPTANCE, SUBJECT TO PRIOR SALE/ SHORT VALIDITY PERIOD' OR CONDITION FOR PRE-DESPATCH INSPECTION OF JUTE BAGS, ANTI SKID HDPE BAGS OR POST SUPPLY OF CHEMICALS ETC. MAY OR MAY NOT BE MADE BY ANY INSPECTION AGENCY/TEST HOUSES ACCEPT OR NOT TO ACCEPT THE CORPORATIONS DECISION WITH REGARD TO THE QUALITY OF MATERIAL etc., super scribed on envelope shall be deemed to be a conditional E-tender and such E-tender document shall not be considered and all such tenders will be summarily rejected. The Managing Director, UKS&TDC Ltd. Does not bind himself to accept the lowest or any other tender and reserves the right to accept the whole or any part of the tender or portion of the quantity offered and the tenderer shall have to supply the same at the rates quoted.

1-15 AGREEMENT:

The successful tenderer shall be bound to execute an agreement within 7 days after having been called upon by notice to do so including the salient features of the accepted tender. The cost of stamping the agreement shall be bound by the successful tenderers. Value of stamp shall be Rs. 100/- at the minimum or as prescribed by the Govt.

1-16 PRINTED TERMS AND CONDITIONS OF TENDERING FIRM NOT ACCEPTABLE:

Printed terms and conditions of the tenderer shall not be considered as forming part of their tenders. In case any terms and conditions of the contract applicable to this invitation to tender are not acceptable to tenderers, they should clearly specify deviation in their tender. The UKS&TDC Ltd. Reserves the right to accept or reject them. The UKS&TDC Ltd. Shall not be bound to give reasons for the refusal to consider the tender with deviations.

INSPECTION:

The successful tenderer of **Chemical shall have to conduct their pre-despatch inspection including breaking load as prescribed from the authorized Inspection Agency at their factory giving prior intimation to them.** Only those consignments having acceptability certificate issued by Inspection Agency will be delivered at different destinations. Post delivery random sampling of Chemical shall also be conducted by the **Committee of the Corporation's officers and their** decision with allied pro-rata deductions, if any, as per terms of Agreement on the quality of material shall be final and binding to the supplier. Similarly sample of all Chemicals shall be sent for testing to the approved test Houses to ascertain its purity as per specifications mentioned in the agreement.

In case the materials do not conform to the required specifications, the same shall be rejected.
